VI. REPORT OF THE FIRE CHIEF – D. Lombardi

Chief Lombardi updated the committee on the current preparations for West Metro's response to COVID-19. COVID-19 has arrived in Colorado. As of today, the state of Colorado has the fifth highest number of cases in the U.S. Chief Aseltine, the Division Chief of Accreditation and Risk Management, is leading the West Metro response. Each and every area of the organization is making proactive adjustments as new information about COVID-19 continues to emerge.

Chief Lombardi added that he is receiving updated information about the virus regularly and that new information could require a modification to the current response at any time. He encouraged CSC members to monitor West Metro's Facebook, Twitter, Instagram, and Youtube channels for additional information.

VII. REPORT OF THE TRAINING CHIEF – D. Pfannenstiel

The first quarter CPR, multi-company drills, and the sleep health trainings are complete.

Preparations are currently underway to reconfigure the Class A fire trainings for the April and May 2020 drills. The drills will include three new rooms and a garage, allowing for new challenges during the training. At this time, Arvada Fire and South Metro Fire are planning to join West Metro for this training.

Looking ahead to the summer, planning has begun for the recruit academy which will begin on July 30, 2020. June and July Class A burns are in the planning stages, and groundwork has begun for the 2020 Lieutenant Exam.

The COVID-19 preparations may soon affect the scheduling of meetings and events held at the Training Center. Chief Pfannenstiel is in the early stages of making alternate plans for previously scheduled external stakeholder events and meetings.

New Hire Written Exam

Nearly 600 people attended the new hire written exam. There was one official challenge to the exam regarding confusion over the time allowed to complete the exam. The challenge has been addressed.

The Physical Agility Test (PAT)

The PAT process is underway and will conclude on March 16, 2020.

Oral Boards

Oral boards are scheduled for March 30 - April 4, 2020 at Administration. The oral board panel has been selected, and includes a diverse pool uniform staff members representing the ranks - firefighter through captain. Oral board questions have also been selected. For paramedic applicants, there is an optional paramedic assessment available where paramedics will be given the opportunity to take an exam to demonstrate paramedic competency with potential for earning additional points. The point allotment is similar to that of points given to applicants with military service.

Chief Pfannenstiel reviewed the 2020 year-to-date budget.

A. 2020 Captain Exam

Work continues on the reading list with plans for the list to be finalized next month.

C. 2020 3rd Grade Firefighter Exam (19-01)
