VII. REPORT OF THE FIRE CHIEF – Fire Chief Don Lombardi

Colorado Task Force 1 (CO-TF1) will be hosting the sponsoring agency Chiefs' meeting for all 28 task forces.

Four West Metro firefighters have been deployed to Los Angeles to assist with the ongoing devastating fires in the area. They will be supported by a Type 6 engine (Brush 9), which will provide the necessary tools and equipment for fire suppression efforts.

VIII. REPORT OF THE TRAINING CHIEF – Division Chief Hutchinson

The Blue Card Incident Command Class (RT130) is currently underway this week. This course is a wildland refresher designed to recertify all firefighters with their red card, which is necessary for wildland firefighting. Additionally, a Driver/Operator Pumper Class, lasting two weeks, is being held, along with a Hazmat Tech Class that runs for two weeks as well. West Metro is also hosting a week-long National Wildland Coordinating Group (NWCG) certification series for wildland firefighting, open not only to West Metro but to other local agencies as well.

A Train the Trainer program for driver trainers is also scheduled, where a corporate trainer will be brought in for a month-long series. In addition, a month-long series of live fire and multi-company drills will take place, focusing on live fire operations and EMS training. Various professional development offerings are also being provided, with support from the Fire Chief.

The 2025-01 Recruit Academy is scheduled to begin on February 3, 2025, with a cohort consisting of 20 recruits from West Metro and 13 recruits from Arvada.
